- Provision of scientific services in research and teaching (2 weekly lecture hours per semester)
- Participation in the preparation and implementation of research projects of the professorship
- Supervision of student theses
- Participation in administrative tasks of the professorship
- Own further scientific qualification (doctorate) in the subject area of the professorship, which focuses on microeconomics and empirical economic research
